- 2. INSTALL NEW HEADPIPES TO CATALYTIC CONVERTERS. TIGHTEN ONLY ENOUGH TO HOLD IN PLACE. LOOSEN U-BOLT HANGER ASSEMBLY FOR LEFT SIDE FORWARD HEADPIPE HANGER AND ADJUST TO ALIGN WITH CROSSMEMBER MOUNT.
- 3. INSTALL MUFFLERS ON END OF HEADPIPES. PUT CLAMPS IN PLACE AND SNUG UP, BUT DO NOT TIGHTEN.
- 4. INSTALL TAILPIPES AND CENTER BUMP OVER REAR HOUSING FOR MAXIMUM CLEARANCE.
- TAILPIPE EXIT HAS BEEN FINISHED TO DUPLICATE FACTORY LOCATION. INSTALL CHROME TIPS.
- MAKE SURE ALL PARTS OF THE SYSTEM ARE CLEAR OF FRAME MEMBERS, ALL HOSES, SUSPENSION AND BRAKE LINES. STARTING AT THE CATALYTIC CONVERTER FLANGES, TIGHTEN ALL CONNECTIONS MAKING SURE ALL PARTS ARE CLEAR AND WILL NOT LEAK OR RATTLE.
- WE RECOMMEND WELDING SLIP CONNECTIONS IF POSSIBLE.

WHEN FINISHED, GIVE YOUR VEHICLE A TEST DRIVE LISTENING CAREFULLY FOR ANY NEW NOISES. AFTER SEVERAL DAYS DRIVING, RETIGHTEN ALL BOLTS.
