IF NO WELDING EQUIPMENT IS AVAILABLE AT THE TIME OF INSTALLATION, USE FURNISHED CLAMPS TO SECURE THE PIPES UNTIL THEY CAN BE WELDED.

INSTALLATION PROCEDURE - PLEASE READ CAREFULLY

- CHOOSE REDUCERS (3" OR 3 1/2") THAT MATCH YOUR HEADERS COLLECTORS. INSTALL REDUCERS USING FLANGES, GASKETS, BOLTS AND NUTS PROVIDED.
- 2. SLIP LARGE END OF FLEX PIPES OVER REDUCERS AND SECURE WITH 2 1/4" U-CLAMPS. INSERT STUBS AND SECURE WITH CLAMPS.
- 3. INSTALL MUFFLERS USING THE SWAGED 15' LONG EXTENSION TUBES TO ACHIEVE DESIRED MUFFLER LOCATION AND SECURE WITH 2 1/4" U-CLAMPS.

NOTE: EXTENSION TUBES MAY BE CUT TO LENGTH AS REQUIRED.

- 4. BEND FLEX TUBE TO ALIGN MUFFLERS, SO THAT THEY ARE LEVEL AND POINTING STRAIGHT BACK.
- 5. INSTALL TAILPIPES (CUT AS NEEDED TO FIT) SO AS TO EXIT IN FRONT OF REAR TIRES AND SECURE WITH 2 1/4" U-CLAMPS.
- 6. MOUNT RUBBER HANGERS IN MOST CONVENIENT LOCATION AND SECURE TO FRAME, CROSSMEMBER OF FLOORBOARD WITH SHEET METAL SCREWS AND LARGE WASHERS. (SEE ILLUSTRATION) SECURE TO TAILPIPES WITH U-CLAMPS.
- ALIGN ALL PIPES, MUFFLERS AND HANGERS. CHECK SYSTEM FOR CLEARANCE AND STARTING AT THE HEADERS, TIGHTEN ALL CONNECTIONS.
- 8. START ENGINE AND CHECK FOR LEAKS. BE SURE ALL BRAKE LINES, FUEL LINES AND ELECTRICAL WIRES HAVE SUFFICIENT CLEARANCE. REPOUTE AS NECESSARY.

WHEN FINISHED, GIVE YOUR CAR A TEST DRIVE CHECKING CAREFULLY FOR ANY NEW NOISES. AFTER SEVERAL DAYS DRIVING, RETIGHTEN ALL BOLTS.
